**A RESOLUTION OF THE CITY OF LIBERTY LAKE, WASHINGTON, RELATING TO
THE FEES CHARGED FOR GOLF AND RECREATIONAL PLAY AND SERVICES
PROVIDED BY THE CITY.**

WHEREAS, the City owns and operates the Trail Head Golf Course;

WHEREAS, the City Council has establish a golf and recreation fund for the purpose of maintenance and general operations of the golf course and related recreational entities in, through and around the City of Liberty Lake; and

WHEREAS, the City is desirous of recovering the cost of services through the imposition of fees and charges where appropriate.

NOW, THEREFORE, the City Council of the City of Liberty Lake, Washington hereby resolves that the following fees and charges shall be collected for use of the Golf Course.





Section 7. Effective Date. This Resolution shall become effective immediately upon passage by the Liberty Lake City Council.


