**A RESOLUTION OF THE CITY OF LIBERTY LAKE AUTHORIZING AND ADOPTING A SIX (6) YEAR TRANSPORTATION IMPROVEMENT PROGRAM FOR 2015 THROUGH 2020.**

WHEREAS, pursuant to RCW 35.77.010, the City of Liberty Lake, Spokane County, Washington ("City") has prepared a six (6) year Transportation Improvement Program ("TIP") for the years 2015 - 2020; and

WHEREAS, the City of Liberty City Council found the TIP to be in compliance with the City's Comprehensive Plan; and

WHEREAS, the City will utilize state and federal grants and low interest loans as necessary to supplement its financial resources, and such anticipated funding is incorporated in the TIP; and


WHEREAS, under RCW 35.77.010, the Liberty Lake City Council held a public hearing on the TIP at City Hall, Liberty Lake, Washington, on June 3, 2014

BE IT FURTHER RESOLVED, that a copy of the TIP, together with a copy of this Resolution, shall be filed with the Office of the Secretary, Washington State Department of Transportation; and

BE IT FURTHER RESOLVED, that City staff is authorized to apply for state and federal grants and low-interest loans in support of and consistent with the projects identified in the TIP.


