## A RESOLUTION WAIVING THE COMPETITIVE BIDDING REQUIREMENTS DUE TO A SOLE SOURCE PURCHASE AND AUTHORIZING THE PURCHASE OF PRECAST GARDEN BEDS

WHEREAS, the City Council finds that based upon findings by the City's Parks and Recreation Department, the purchase of precast garden beds is appropriate due to the exclusiveness and quality of the product; and

WHEREAS, RCW 39.04.280 provides that a local agency, by Resolution, may waive the competitive bidding requirements when the purchase is clearly and legitimately limited to a single source of supply, or when the purchase involves special facilities or market conditions; and

WHEREAS, the City Council finds that there is one precast garden bed supplier that will satisfy the City's needs, and that the proximity of the sole source supplier and manufacturer is a special market condition; and

WHEREAS, the City Parks and Recreation Department consulted with various other suppliers and determined that such suppliers were incapable of satisfying the City's needs; and

WHEREAS, it is appropriate for the City Council under RCW 39.04.280 to waive the competitive bidding requirements for the above reasons; and

NOW, THEREFORE, it is hereby resolved by the City Liberty Lake City Council the following:

- 1. Pursuant to RCW 39.04.280, the competitive bidding requirements for the purchase of precast garden beds for the City's Arboretum is waived as a sole source purchase and within the near vicinity, and
- 2. The City is authorized to purchase precast garden beds manufactured by Wilbert Precast, Inc., in the amount of \$6,581.79.
