

LIBERTY LAKE REGIONAL PARK CAMPGROUND INFORMATION & RULES

CAMPGROUND INFORMATION

FEES

- Tent camping is \$20-\$22 per day and includes entry fees for 4 people and 1 vehicle per site.
- R.V. camping is \$28-\$32 per day and includes entry fees for 4 people and 2 vehicles per site. Example, an RV plus a towing truck, tow behind car or separate vehicle.
- Group camping is \$34-\$40 per day and includes entry fees for 12 people and 3 vehicles per site. Group camping is limited to the Group Tent Site.
- Additional person(s) are \$2 per day with a maximum of 8 people per tent/RV site and 16 people per group site.
- Additional vehicles are \$5 per day. Additional vehicles that do not fit within your site's designated parking area must be relocated to the overflow parking area or main lot at the park entrance.
- Firewood is \$5.00 per bundle.
- Reservation fee is \$7 per reservation. Reservations can be made online at www.spokanecounty.org/parks or by calling (509) 477- 4730.

CAMPING

- If you are staying at the campground, you must camp only in those places specifically provided or marked.
- All vehicles, RVs, and trailers must be parked on your campsite driveway. Driving or parking off road is prohibited.
- Check-In Time: 2:00 pm. Check-Out time: 11:00 am. For early check-in, confirm with Campground Host.
- 14 night maximum stay.
- Quiet hours are between 10:00 pm and 7:00 am.
- Upon arrival, all campers must stop at information station and check-in with Campground Host before occupying campsite.
- Upon check-in, place your vehicle permit on driver side of dash and attach camping permit to campsite post. Additional vehicles are \$5 per day and must be parked outside the campground in the overflow parking area or main lot at the park entrance.
- Campsites must be occupied nightly.
- Spokane County is not responsible for any loss or damage to personal property.
- Keep noise at a reasonable level that will not disturb other campers and park visitors.

RESERVATIONS

- Take the stress out of planning your stay! Reservation fee is \$7 per reservation. Reservations can be made online at www.spokanecounty.org/parks or by calling (509) 477- 4730.
- Online reservations are available 24 hours a day for your convenience.
- Reservations by phone are available Monday – Friday, 8:00 am – 4:30 pm (PST) at (509) 477-4730.
- Reservations can be made 12 months in advance of your intended stay, but no later than two days prior to your arrival.
- Cancellations/Refund Policy: For all camping reservation cancellations (including cabin reservations), Spokane County must receive notice from the Reservation Holder and will be subject to the following policies:
 - If notification is received from the Reservation Holder at least 14 calendar days prior to the reserved date(s), the \$7 reservation fee will be retained by Spokane County and all other funds will be returned.
 - If notification is received from the Reservation Holder less than 14 calendar days prior to the

reserved date(s), Spokane County will retain the \$7 reservation fee and 50% of the reservation bill for each night's stay that is within the 14 calendar day period, and all other funds will be returned.

- For cabin rentals only, if **notification of cancellation is received from the Reservation Holder less than two (2) calendar days** prior to their reserved date(s), 100% of each night's stay that is within the two (2) calendar day period will be retained by Spokane County and other funds will be returned after applying other applicable refund policies (see above).

CAMPGROUND RULES

SANITATION

- All garbage and litter must be disposed of at the dump station or taken with you when you leave.
- No dumping of any kind shall occur outside of proper receptacles/containers.

CAMPFIRES

- Open fires may be prohibited at certain times during high fire season.
- Fires shall only be built in fire rings, stoves, grills, or fireplaces intended for that purpose.
- Do not leave your fire unattended. Completely extinguish fire before leaving. You are responsible for keeping fires under control.
- Do not put cans, bottles, plastic, food or rocks in fire ring.
- Do not start campfires with gasoline or camping fuel.
- Keep flammable materials away from campfires.
- Follow fire restrictions when in place.

VEHICLE OPERATIONS

- Drivers must obey all traffic signs and operate their vehicle in accordance with posted regulations, and applicable Federal, State and local laws.
- All motorized vehicles, camping units, and trailers must stay on designated roads, parking areas, or camping pads.
- Use of vehicles within campground is limited to entering or leaving the campground on authorized roadways.
- When operating vehicles of any kind, do not damage the land or vegetation, nor disturb wildlife.

PETS AND ANIMALS

- Pets must be restrained or on a leash no longer than 6 feet at all times.
- No more than 2 dogs per site.
- Dogs shall not be left barking or unattended. If your dog is disrupting others, you may be asked to leave.
- Owners are responsible for cleaning up waste from their dogs.
- Do not gather, collect, or harm plants or wildlife. Feeding of wildlife is strictly prohibited.
- Pets (except service animals) are not allowed in swimming areas or sanitary facilities.
- Saddle or pack animals are only allowed where authorized by posted instructions.

FIREWORKS/WEAPONS

- Discharge of fireworks, firearms, explosives, incendiary devices, bow and arrows, wrist-rockets, paintball guns, airsoft guns or other weapons is prohibited.

PUBLIC PROPERTY

- Leave no trace. Leave natural areas better than you found them.
- Cutting trees and shrubs or damaging natural resources is prohibited.

GENERAL NOTICE

- All visitors and users are subject to federal, state and local laws.
